BCK GIVES A BOOK A MONTH THROUGH-OUT THE SCHOOL YEAR TO CHILDREN IN PRE-K, KINDERGARDEN, FIRST- AND SECOND-GRADE CLASSROOMS, THE CRITICAL AGE FOR DEVELOPMENT OF READING SKILLS.
